
1. Cycling Southampton Delivery Plan 2017-2020

Cycling Southampton is an ambitious vision for Southampton to become a true Cycling City, it is a transformational 10 year plan for cycling in Southampton. This is the Delivery Plan for the first 3 years of the Strategy covering the period from 2017 to 2020, setting out how we intend to spend our confirmed funds and resources on the activities and schemes in the Straetgy.

2. Funding

Southampton City Council is committed to the continual improvement and expansion of a safe cycle network and promotion of cycling as a normal everyday way of getting around. The estimated cost of delivering *Cycling Southampton* is approximately £25m over 10 years, this first Delivery Plan for 2017-2020 is estimated to have a value of £11m – we have secured funding to do this work from a combination of different sources this shown below.

The primary source will be the Local Transport Plan Integrated Block (LTPIB) which is allocated from Government annually to SCC at approximately £2.12m, and this amount is known until 2020/21. We will seek to allocate similar levels to previous years (usually between £0.5-1.0m) of LTPIB money to deliver Theme 1 cycling schemes, confirmed for 2017/18. Alongside this core funding there are other LTPIB programme schemes that will provide improvements for cycling such as road safety, junction enhancements, public realm or public transport projects. For



all the schemes the design approach will seek to put cycle safety to centre.

Over the first two years of the programme SCC has allocated £1.5m from the Roads Programme of highway maintenance to cycleway and footway maintenance. This will enable targeted maintenance of the cycle network to make it smoother, safer and easier to cycle.

In addition to the core funding for cycling through the Council's programmes, we seek to use external sources to supplement to money available. We regularly bid to external sources such as the Government, Solent LEP, EU and other sectors such as the voluntary or businesses. Where new developments are planned we can use developer contributions (known as Section 106 or Section 278 Agreements) to ensure that they contribute to the growth of the SCN.

For this Delivery Plan we were have secured funding from a variety of external sources that will deliver a considerable proportion of the Plan,

 A £3.2m joint bid, with Hampshire County Council, to the Department for Transport's 2016 Access Fund¹ to deliver the initiatives and schemes in Themes 2 and 3, including first phase of the Legible Cycling wayfinding, engagement activities in

- schools and workplaces to encourage more pupils and employees to cycle, the Southampton Cycle Festival, promotional activities and training;
- £500,000 from DEFRA towards building facilities along SCN1 (Western Cycle Route) as part of the preparations for the Clean Air Zone in 2019;
- As part of the £644,000 from the National Productivity Investment Fund (NPIF) will be used to upgrade and develop cycle facilities on Stoneham Way on SCN6 (Portswood) to Swaythling station;
- Investment by Highways England on M271 Redbridge Roundabout and along the A3024 corridor (SCN10) will benefit cyclists with new facilities, safer crossing points and wayfinding; and
- Bids to Government for major roads maintenance at Millbrook Roundabout and cycle facilities and junction improvements along Bursledon Road.

3 Partnership

SCC can lead on the delivery of the strategy, however we cannot deliver this alone. To get the transformation everyone wants the plan will require **partnership working**, by continuing our proven track record of working with the public and organisations.

Key partners to delivery are:

- Central Government departments such as Department for Transport (DfT) and DEFRA, Highways England, neighbouring local authorities, Solent Transport, and other departments in SCC;
- National organisations such as Sustrans, Cycling UK and British Cycling;
- Local organisations such as the Solent Local Enterprise Partnership (LEP), both Universities, the NHS Trust and Public Health, the Port of Southampton, Hampshire Constabulary, local cycling and volunteer groups such as Southampton Cycle Campaign and forums, schools and colleges in the city, and private sector developers, businesses and employers; and
- Residents of Southampton.

4 Cycling Southampton Delivery Plan 2017-2020

The first three years of *Cycling Southampton* are set out in three year the Delivery Plan 2017-2020. The programme for 2017/18 is confirmed with a value of £5.2m, the programme for 2018/19 and 2019/20 is indicative and will be confirmed in the February of each year. Final figures and future annual budgets will be dependant on the future success of SCC in securing additional external funds. It shows that through Theme 1 Better Cycling the SCN will be developed incrementally, starting in these three years we aim to develop a corridor a year ready for implementation in subsequent years. This will be supported by Theme 2 Safe & Easy Cycling and Theme 3 Inspiring Cycling as a holistic programme to increase the number of people cycling in Southampton more often and safely.
