

PUBLIC NOTICE

THE CITY OF SOUTHAMPTON (WAITING RESTRICTIONS AMENDMENT 2) ORDER 2021

NOTICE IS HEREBY GIVEN THAT SOUTHAMPTON CITY COUNCIL proposes to make the above Order, the effects of which would be:

- A. To introduce No Waiting at Any Time restrictions in the following lengths of road:
- 1 **Bitterne Road Precinct Footpath (Part)**, *south-eastern closed end*, For its entire length, across the bollards, adjacent to the Red Lion entrance; *both sides*, From its junction with Bursledon Road (Western Cul-de-Sac Section) north-westwards for 7m
 - 2 **Bursledon Road (Western Cul-de-Sac Section)**, *north side*, From the extended south-western kerb line of Maybray-King Way north-westwards to the north-western closed end of Bitterne Road Precinct Footpath, *south side*, From the closed end of Bitterne Road Precinct Footpath (Part) south-eastwards for 25m.
 - 3 **Carpathia Drive**, *both sides*, From the northern kerb line of Marsh Lane industrial estate road, northwards to a point 10m north of the northern kerb line of Whitestar Place
 - 4 **Exeter Road**, *both sides*, From of its junction with Vanguard Road north-eastwards for 10m.
 - 5 **Lawn Road**, *north side*, From a 185m east of the Western Closed End of Lawn Road eastwards for 5m.
 - 6 **Luccombe Road**, *west side*, From 15m south-east of its junction with Winchester Road to 10m south of its junction with Pewsey Place.
 - 7 **Pinegrove Road**, *both sides*, From the southern kerblines of South East Road southwards for 13m.
 - 8 **Richmond Road**, *north side*, From 10m west to 10m east of its junction with Trafalgar Road.
 - 9 **South East Road**, *south side*, From 10m east of the eastern kerblines of Pinegrove Road to 10m west of the western kerblines of Pinegrove Road.
 - 10 **South View Road**, *both sides*, From the north-eastern kerb-line of St James Road north-eastwards for 10m.
 - 11 **St James Road**, *north-east side*, From 10m north-west of the north-west kerb-line of South View Road to 10m south-east of the south-eastern kerb-line of South View Road.
 - 12 **Spring Crescent**, *south-west side*, From 2m north of the south-eastern closed end north-westwards for 18m.
 - 13 **Thornhill Road**, *both sides*, From 32m north-west of its junction with Highclere Road north-westwards for 20m (highway boundary)
 - 14 **Trafalgar Road**, *both sides*, From the junction with Richmond Road northwards for 10m
 - 15 **Vanguard Road**, *north-east side*, From 13m north-west to 13m south-east of its junction with Exeter Road.
 - 16 **Victoria Road**, *south side*, From 10m west of the western kerb line of Dundonald Close westwards for 40m; From 10m east of the eastern kerb line of Dundonald Close eastwards for 40m.
 - 17 **Whitestar Place**, *north-east side*, From the western kerb line of Carpathia Drive westwards for 10m, *southwest & west*, For its entire length, including the turning circle, *northern closed end*, For its entire length.
- B. To introduce No Waiting, 8am-6pm, Mon-Sat, 1-6pm Sun, in the following lengths of road:
1. **Carpathia Drive**, *both sides*, From 10m north of the northern kerblines of Whitestar Place northwards for all sides.
 2. **White Star Place**, *north-east and east side*, From 10m north-west of the north-western kerblines of Carpathia Drive northwest and northwards for its entire length.
- C. To introduce No Loading at Any Time in **Mount Pleasant Road**, *north-east side*, From its junction with Bevois Valley Road south-eastwards for 72m.

Any person wishing to object or make any other representation relating to this Order must do so in writing via the Councils website: transport.southampton.gov.uk/TRO or by post to the Highways Legal Team at Southampton City Council, Civic Centre, Southampton, SO14 7LY quoting the notice title and stating the grounds for objection, within 28 days of the date of this Notice (i.e. by 7th January 2022). Please note that an extra week has been allowed for the consultation over the holiday period.
