

# PUBLIC NOTICE

## THE CITY OF SOUTHAMPTON (VARIOUS ROADS) (SPEED LIMITS) (AMENDMENT 15) ORDER 2022

NOTICE IS HEREBY GIVEN THAT SOUTHAMPTON CITY COUNCIL proposes to make the above Order, the effects of which would be:

1. To introduce a 20mph speed limit on the following lengths of roads (for their entire extents):

Ashwood Gardens, Aspen Holt, Aster Road, Avington Court, Bassett Avenue Service Road (No's. 55 – 71), Bassett Close, Bassett Crescent East, Bassett Crescent West, Bassett Gardens, Bassett Green Close, Bassett Green Drive, Bassett Green Village, Bassett Meadow, Bassett Wood Drive, Beaumont Close, Beechmount Road, Begonia Road, Bluebell Road, Brindle Close, Burgess Gardens, Butterfield Road, Carnation Road, Chelwood Gate, Chetwynd Drive, Chetwynd Road, Copperfield Road, Courtland Gardens, Daffodil Road, Dahlia Road, Daisy Road, Denbigh Gardens, Elmsleigh Gardens, Evesham Close, Fernlea Gardens, Glen Eyre Drive, Glen Eyre Road, Glen Eyre Way, Glencarron Way, Glenwood Avenue, Grendon Close, Honeysuckle Road, Horder Close, Hurlingham Gardens, Iris Road, Laburnum Road, Lilac Road, Lobelia Road, Lupin Road, Meadowhead Road, Northwood Close, Pansy Road, Phillimore Road, Pointout Close, Pointout Road, Poppy Road, Primrose Road, Redwood Way, Shawford Close, Sherwood Close, Spindlewood Close, The Catkins, The Mayflowers, The Parkway, Tower Gardens, Tudor Wood Close, Tulip Road, Violet Road, Willis Road, Winchester Road Service Road (No's. 473 – 483), and Woodview Close
