

PUBLIC NOTICE

THE CITY OF SOUTHAMPTON (HILL LANE) ORDER 2022

NOTICE IS HEREBY GIVEN THAT SOUTHAMPTON CITY COUNCIL proposes to make the above Order, the effects of which would be:

1. To introduce the following Mandatory With-Flow Cycle Lanes in **Hill Lane**:
 - a. *West side*, From 4.5m north of the northern kerbline of Atherley Court northwards for 85.5m (tied into the existing advisory cycle lane)
 - b. *West side*, From 4m north of the southern boundary of 206 Hill Lane northwards for 36.5m
 - c. *West side*, From 81.5m north of the southern boundary of 206 Hill Lane to 14.5m south-east of the southern kerbline of Bellemoor Road
 - d. *East side*, From 30m south-east of the extended southern kerbline of Bellemoor Road southwards to the boundary between 155 Hill Lane and 157 Hill Lane
 - e. *East side*, From 16.5m south of the boundary between 155 Hill Lane and 157 Hill Lane southwards for 66m
 - f. *East side*, From 291m south of the boundary between 155 Hill Lane and 157 Hill Lane to 11m north of the extended northern kerbline of Atherley Court (tied into existing advisory cycle lane)

It is also intended to introduce an advisory with-flow cycle lane in **Hill Lane**, *East side*, From 82.5m south of the boundary between 155 Hill Lane and 157 Hill Lane southwards for 196.5m.

Note associated lengths of Cycle Track are also being proposed, the details of which are provided in the (Hill Lane) (Cycle Facilities) Notice 2022.
