## THE CITY OF SOUTHAMPTON <br> (PROHIBITION AND RESTRICTIONS OF WAITING) (AMENDMENT 79) ORDER 2022

Southampton City Council in exercise of its powers under Sections 1, 2 and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984 and of all other enabling powers, after consultation with the Chief Office of Police in accordance with Part III of Schedule 9 to that Act hereby makes the following Order:

## CITATION

1 This Order shall come into operation on DATE 2022 and may be cited as The City of Southampton (Various Roads) (Prohibition and Restrictions of Waiting) (Amendment 79) Order 2022.

## INTERPRETATION

2 In this Order:
(i) "Principal Order" means the City of Southampton (Various Roads) (Prohibition and Restriction of Waiting) Traffic Regulation Order 2011, as amended.
(ii) Except where otherwise stated, any reference to an Article or Schedule shall be construed as a reference to that Article or Schedule in this Order.
(iii) Any reference to an enactment shall be construed as a reference to that enactment as amended by any subsequent enactments.

## AMENDMENTS

3 The following shall be inserted into the Principal Order as a new Article 10D:
"10D NO STOPPING EXCEPT POLICE VEHICLES
(1) No person shall cause or permit any vehicle other than a police vehicle to stop of wait in the lengths of road specified in Schedule 5.14.
(2) Nothing in Article 10D sub-section (1) shall apply:
(a) a vehicle stopping or waiting for so long as may be necessary to enable the vehicle to be used in connection with any building operation or demolition; the removal of any obstruction to traffic; the maintenance, improvement or reconstruction of the road comprising or including that carriageway; or the laying, erection, alteration or repair in or on land adjacent to the said lengths of road or side of road of any sewer, or of any main pipe or apparatus for the supply of gas, water or electricity or of any telecommunication apparatus;
(b) to a vehicle being used for fire brigade, ambulance or police purposes.

4 The contents of Schedule 1 shall be deleted from Schedule 2.01 to the Principal Order.
5 The contents of Schedule 2 shall be inserted into Schedule 2.01 to the Principal Order.
6 The contents of Schedule 3 shall be inserted into the Principal Order as a new Schedule 5.14 .
