

PUBLIC NOTICE

THE CITY OF SOUTHAMPTON (WOOLSTON & ITCHEN ATZ) ORDER 2022

NOTICE IS HEREBY GIVEN THAT SOUTHAMPTON CITY COUNCIL proposes to make the above Order, the effects of which would be:

1. To introduce no waiting at any time restrictions in the following locations:
 - a. **Radstock Road**, *south side*, For the remaining unrestricted extent of the section between Manor Road South and Cheddar Close (disabled parking bay to be retained); *north side*, From the western edge of the bus stop layby (opposite 34 Radstock Road) westwards for 46m
 - b. **Manor Road South**, *both sides*, From 15m south of its junction with Radstock Road, southwards for 2m
 - c. **West Road**, *east side*, From the southern boundary of No. 4 West Road southwards to Obelisk Road; *west side*, From the southern boundary of the hardstanding to the rear of No. 91 Obelisk Road, southwards to Obelisk Road
 - d. **Obelisk Road**, *south side*, From the extended western flank wall of 20A Obelisk Road, westwards to the existing no waiting at any time restrictions
 - e. **John's Road**, *east side*, in place of the permit holders and limited waited parking bay outside of the Co-op
 - f. **Archery Road**, *both sides*, From 65m north-west of its junction with Bevan Close north-westwards for 42m, From 127m north-west of Bevan Close north-westwards for 53m; *south-west side*, From 204m north-west of Bevan Close north-westwards for 38m; *north-east side*, From 204m north-west of Bevan Close north-westwards for 52m (to support traffic calming buildouts)
2. To relocate the limited waiting and permit holders parking bay in **Obelisk Road**, *south side*, opposite Cox's Lane. The bay would be moved to: **Obelisk Road**, *south side*, From 81m east of the eastern kerblines of Victoria Road eastwards for 44m. No waiting at any time restrictions will replace the existing bay.
