

THE CITY OF SOUTHAMPTON (MOVING TRAFFIC RESTRICTIONS) ORDER 2022

Southampton City Council in exercise of its powers under Sections 1, 2, 4 and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984 and of all other enabling powers and after consultation with the Chief Office of Police in accordance with Part III of Schedule 9 of the same Act, makes the following Order:

PART ONE – INTRODUCTION

CITATION

- 1.1** This Order will come into operation on [DATE] and may be cited as The City of Southampton (Moving Traffic Restrictions) Order 2022.

INTERPRETATION

- 1.2** In this Order:

- (a) except where otherwise stated, any reference to an article, part, or schedule will be interpreted as a reference to that Article or Schedule in this Order.
- (b) any reference to an Act, Statutory Instrument or Order will be interpreted as a reference to that Act, Statutory Instrument or Order as amended.
- (c) in the description of the length of road to which a restriction will apply, any reference to a direction with the suffix '-wards' (for example northwards or south-westwards) will not be interpreted as limiting the application of that restriction to traffic traveling in the direction specified. Where a restriction is applicable to traffic travelling in a particular direction only, this will be indicated with the use of the suffix '-bound' and 'traffic only' (for example northbound traffic only or south-westbound traffic only).

- 1.3** The following expressions have the respective meanings assigned to them in this Order:

“Authorised Vehicle” means any vehicle or class of vehicle as specified in schedule A.

“Bus Lane” means the areas of carriageway described in columns 1, 2 and 3 of schedule 18 separated from another part of the carriageway by a road marking to Schedule 9, Part 6, Item 11 of the TSRGD.

“Bus” means a motor vehicle constructed or adapted to carry more than 8 passengers (exclusive of the driver) and local buses not so constructed or adapted.

“Contra-flow Bus Lane” means the areas of carriageway described in columns 1, 2 and 3 of schedule 18 separated from another part of the carriageway by a road marking to Schedule 9, Part 6, Item 11 of the TSRGD.

“Contra-flow Cycle Lane” means the areas of carriageway described in columns 1, 2 and 3 of schedule 22 separated from another part of the carriageway by a road marking to Schedule 9, Part 6, Item 7 of the TSRGD.

“Council” means Southampton City Council.

“Disabled Persons vehicle” means a vehicle Displaying a valid disabled persons badge in accordance with The Disabled Persons (Badges for Motor Vehicles) (England) Regulations 2000.

“Goods Vehicle” means a motor vehicle or trailer constructed or adapted for use for the carriage or haulage of goods or burden of any description.

“Local Bus” means a Public Service Vehicle used for the provision of a local service not being an excursion or tour.

“Local Service” has the meaning given in section 2 of the Transport Act 1985.

“Mandatory Cycle Lane” means the areas of carriageway described in columns 1, 2 and 3 of schedule 21 separated from another part of the carriageway by a road marking to Schedule 9, Part 6, Item 7 of the TSRGD.

“Maximum Gross Weight” means: (a) in the case of a motor vehicle not drawing a trailer or in the case of a trailer, its Maximum Laden Weight; (b) in the case of an articulated vehicle, its maximum laden weight (if it has one) and otherwise the aggregate Maximum Laden Weight of all the individual vehicles forming part of that articulated vehicle; (c) in the case of a motor vehicle (other than an articulated vehicle) drawing one or more trailers, the aggregate Maximum Laden Weight of the motor vehicle and the trailer or trailers drawn by it.

“Maximum Laden Weight” means: (a) in the case of a vehicle which a gross weight not to be exceeded in Great Britain is specified in construction and use requirements (as defined by section 41(7) of the Road Traffic Act 1988(23)), the weight so specified; (b) in the case of a vehicle as respects which no such weight is so specified, the weight which the vehicle is designed or adapted not to exceed when in normal use and travelling on a road laden.

“Motor Vehicle” means a mechanically propelled vehicle intended or adapted for use on roads.

“Motorcycle” means a vehicle with fewer than 3 wheels, of which the weight unladen does not exceed 410 kilograms.

“Pedal Cycle” means a unicycle, bicycle, tricycle, or cycle having four or more wheels, not being in any case mechanically propelled unless it is an electrically assisted pedal cycle of such class as is to be treated as not being a motor vehicle for the purposes of the Road Traffic Regulation Act 1984.

“Permit” means an authorisation issued by the Council in accordance Part 7 which exempts a vehicle, person or organisation from a moving traffic restriction.

“Public Service Vehicle” has the meaning given in section 1 of the Public Passenger Vehicles Act 1981.

“Stadium Event Days” means the hours which the Council consider it necessary for the restrictions to apply in connection with a football match or other event being held at St Mary’s Stadium, Southampton.

“TSRGD” means The Traffic Signs Regulations and General Directions 2016.

“Vehicle” means a mechanically propelled vehicle, intended or adapted for use on roads.

PART TWO – COMPULSORY AND PROHIBITED MOVEMENTS

COMPULSORY MOVEMENTS

- 2.1** A vehicle travelling along a length of road specified in column 1 of schedule 1, in the direction specified in column 2 of schedule 1, during the hours specified in column 5 of schedule 1, must make the movement described in column 3 of schedule 1 into the length of road specified in column 4 of schedule 1.
- 2.2** Article 2.1 does not apply to a vehicle of a type specified in column 6 of schedule 1

PROHIBITED MOVEMENTS

- 2.3** A vehicle travelling along a length of road specified in column 1 of schedule 2, during the hours specified in column 4 of schedule 2 must not make the movement described in column 2 of schedule 2 into the length of road specified in column 3 of schedule 2.
- 2.4** Article 2.3 does not apply to a vehicle of a type specified in column 6 of schedule 2

NO ENTRY

- 2.5** A vehicle travelling along a length of road specified in column 1 of schedule 3, during the hours specified in column 3 of schedule 3, must not enter the length of road specified in column 2 of schedule 3.
- 2.6** Article 2.5 does not apply to a vehicle of a type specified in column 6 of schedule 3.

ONE-WAY ROADS

- 2.7** A vehicle travelling along a length of road specified in column 1 and 2 of schedule 4 must travel in the direction specified in column 3 of schedule 4.

ONE-WAY EXCEPT CYCLES

- 2.8** A vehicle travelling along a length of road specified in column 1 and 2 of schedule 5 must travel in the direction specified in column 3 of schedule 5, unless that vehicle is a Pedal Cycle.

PART THREE – PROHIBITION OF TRAFFIC

PROHIBITION OF VEHICLES

- 3.1** A vehicle must not enter or travel along a length of road specified in columns 1 and 2 of schedule 6 during the hours specified in column 3 of schedule 6.
- 3.2** Article 3.1 does not apply to:
- (a) a vehicle of a type specified in column 4 of schedule 6, or
 - (b) a vehicle being used for a purpose specified in column 4 of schedule 6.

PROHIBITION OF MOTOR VEHICLES

- 3.3** A Motor Vehicle must not enter or travel along a length of road specified in columns 1 and 2 of schedule 7 during the hours specified in column 3 of schedule 7.
- 3.4** Article 3.3 does not apply to:
- (a) a vehicle of a type specified in column 4 of schedule 7, or
 - (b) a vehicle being used for a purpose specified in column 4 of schedule 7

PROHIBITION OF BUSES

- 3.5** A Bus must not enter or travel along a length of road specified in columns 1 and 2 of schedule 8 during the hours specified in column 3 of schedule 8.
- 3.6** Article 3.5 does not apply to:
- (a) a vehicle of a type specified in column 4 of schedule 8, or
 - (b) a vehicle being used for a purpose specified in column 4 of schedule 8.

PROHIBITION OF GOODS VEHICLES WITH A MAXIMUM GROSS WEIGHT GREATER THAN 7.5 TONNES

- 3.7** A Goods Vehicle with a Maximum Gross Weight greater than 7.5 tonnes must not enter or travel along a length of road specified in columns 1 and 2 of schedule 9 during the hours specified in column 3 of schedule 9.
- 3.8** Article 3.7 does not apply to:
- (a) a vehicle of a type specified in column 4 of schedule 9, or
 - (b) a vehicle being used for a purpose specified in column 4 of schedule 9.

PROHIBITION OF HORSE-DRAWN VEHICLES

3.9 A horse-drawn vehicle must not enter or travel along a length of road specified in columns 1 and 2 of schedule 10 during the hours specified in column 3 of schedule 10.

3.10 Article 3.9 does not apply to:

- (a) a vehicle of a type specified in column 4 of schedule 10, or
- (b) a vehicle being used for a purpose specified in column 4 of schedule 10.

PROHIBITION OF CYCLING

3.11 A Pedal Cycle must not enter or travel along a length of road or footpath specified in columns 1 and 2 of schedule 11.

STRUCTURAL WEIGHT LIMIT

3.12 A vehicle with a Maximum Gross Weight greater than that specified in column 3 of Schedule 12 must not enter or travel along a length of road specified in columns 1 and 2 of schedule 12.

WIDTH LIMIT

3.13 A vehicle with a width greater than that specified in column 3 of Schedule 13 must not enter or travel along a length of road specified in columns 1 and 2 of schedule 13 during the hours specified in column 4 of schedule 13.

3.14 Article 3.13 does not apply to:

- (a) a vehicle of a type specified in column 5 of schedule 13, or
- (b) a vehicle being used for a purpose specified in column 5 of schedule 13.

LENGTH LIMIT

3.15 A vehicle with a length greater than that specified in column 3 of Schedule 14 must not enter or travel along a length of road specified in columns 1 and 2 of schedule 14 during the hours specified in column 4 of schedule 14.

3.16 Article 3.15 does not apply to:

- (a) a vehicle of a type specified in column 5 of schedule 14, or
- (b) a vehicle being used for a purpose specified in column 5 of schedule 14.

HEIGHT LIMIT

3.17 A vehicle with a height greater than that specified in column 3 of Schedule 15 must not enter or travel along the lengths of road specified in columns 1 and 2 of schedule 15.

PEDESTRIAN ZONES

3.18 A vehicle must not enter or travel along a length of road specified in columns 1 and 2 of schedule 16 during the hours specified in column 3 of schedule 16.

3.19 Article 3.18 does not apply to:

- (a) a vehicle of a type specified in column 4 of schedule 16, or
- (b) a vehicle being used for a purpose specified in column 4 of schedule 16.

PEDESTRIAN AND CYCLE ZONES

3.20 A Motor Vehicle must not enter or travel along a length of road specified in columns 1 and 2 of schedule 17 during the hours specified in column 3 of schedule 17.

3.21 Article 3.20 does not apply to:

- (a) a vehicle of a type specified in column 4 of schedule 17, or
- (b) a vehicle being used for a purpose specified in column 4 of schedule 17.

PART FOUR – BUS FACILITIES

WITH-FLOW BUS LANE

4.1 A vehicle must not enter or travel along a Bus Lane specified in columns 1, 2 and 3 of schedule 18 during the hours specified in column 4 of schedule 18, unless that vehicle is of a type specified in column 5 of schedule 18.

4.2 Article 4.1 does not apply to:

- (a) a vehicle being used by a licensed universal postal service provider for the purpose of sorting, delivering or collecting postal packets in the course of the provision of a universal postal service as defined in Part 3 of the Postal Services Act 2011.
- (b) a vehicle entering or exiting from a road or off-street premises where such access is only possible from within the Bus Lane, provided that the vehicles does not travel along the Bus Lane for longer than is necessary.

4.3 A vehicle must not wait within a Bus Lane specified in columns 1, 2 and 3 of schedule 18 during the hours specified in column 6 of schedule 18.

4.4 Article 4.3 does not apply to:

- (a) any vehicle being used by a licensed universal postal service provider for the purpose of sorting, delivering or collecting postal packets in the course of the provision of a universal postal service as defined in Part 3 of the Postal Services Act 2011

CONTRA-FLOW BUS LANE

4.5 A vehicle travelling along a length of road specified in column 1 and 2 of schedule 19, must travel in the direction specified in column 4 of schedule 19, unless that vehicle is of a type specified in column 5 of schedule 19 travelling within a Contra-flow Bus Lane.

4.6 A vehicle must not enter or travel along a Contra-flow Bus Lane specified in in column 1 and 2 of schedule 19, unless that vehicle is of a type specified in column 5 of schedule 19.

4.7 Articles 4.5 and 4.6 do not apply to:

- (a) a vehicle being used by a licensed universal postal service provider for the purpose of sorting, delivering or collecting postal packets in the course of the provision of a universal postal service as defined in Part 3 of the Postal Services Act 2011.
- (b) a vehicle entering or exiting from a road or off-street premises where such access is only possible from within the Contra-flow Bus Lane, provided that the vehicles does not travelling along the Contra-flow Bus Lane for longer than is necessary.

4.8 A vehicle must not wait within a Contra-flow Bus Lane specified in columns 1, 2 and 3 of schedule 19 during the hours specified in column 6 of schedule 19.

4.9 Article 4.8 does not apply to:

- (a) any vehicle being used by a licensed universal postal service provider for the purpose of sorting, delivering or collecting postal packets in the course of the provision of a universal postal service as defined in Part 3 of the Postal Services Act 2011

BUS-ONLY STREETS & BUS GATES

- 4.10** A vehicle must not enter or travel along a length of road specified in columns 1 and 2 of schedule 20 during the hours specified in column 3 of schedule 20, unless that vehicle is of a type specified in column 4 of schedule 20.
- 4.11** Article 4.10 does not apply to:
- (a) a vehicle being used by a licensed universal postal service provider for the purpose of sorting, delivering or collecting postal packets in the course of the provision of a universal postal service as defined in Part 3 of the Postal Services Act 2011.

PART FIVE – CYCLE FACILITIES

MANDATORY WITH-FLOW CYCLE LANE

- 5.1** A vehicle must not enter or travel along a Mandatory Cycle Lane specified in columns 1, 2 and 3 of schedule 21 during the hours specified in column 4 of schedule 18, unless that vehicle is a Pedal Cycle.
- 5.2** Article 5.1 does not apply to:
- (a) a vehicle being used by a licensed universal postal service provider for the purpose of sorting, delivering or collecting postal packets in the course of the provision of a universal postal service as defined in Part 3 of the Postal Services Act 2011.
 - (b) a vehicle entering or exiting from a road or off-street premises where such access is only possible from within the Mandatory Cycle Lane, provided that the vehicles does not travel along the Mandatory Cycle Lane for longer than is necessary.
- 5.3** A vehicle must not wait within a Mandatory Cycle Lane specified in columns 1, 2 and 3 of schedule 18 during the hours specified in column 4 of schedule 18.
- 5.4** Article 5.3 does not apply to:
- (a) any vehicle being used by a licensed universal postal service provider for the purpose of sorting, delivering or collecting postal packets in the course of the provision of a universal postal service as defined in Part 3 of the Postal Services Act 2011

MANDATORY CONTRA-FLOW CYCLE LANE

- 5.5** A vehicle travelling along a length of road specified in column 1 and 2 of schedule 22, must travel in the direction specified in column 4 of schedule 22, unless that vehicle is a Pedal Cycle travelling within a Contra-flow Cycle Lane.
- 5.6** A vehicle must not enter or travel along a Contra-flow Cycle Lane specified in in column 1 and 2 of schedule 22 unless that vehicle is a Pedal Cycle.
- 5.7** A vehicle must not wait within a Contra-flow Cycle Lane specified in columns 1, 2 and 3 of schedule 22 during the hours specified in column 5 of schedule 22.
- 5.8** Article 5.7 does not apply to:
- (a) any vehicle being used by a licensed universal postal service provider for the purpose of sorting, delivering or collecting postal packets in the course of the provision of a universal postal service as defined in Part 3 of the Postal Services Act 2011

PART SIX – EXEMPTIONS

GENERAL EXEMPTIONS

- 6.1** No provision of this order will apply to:

- (a) A vehicle being used for at least one of the following purposes and observance of the provision of this order would be likely to hinder the use of that vehicle for the purpose for which it is being used:
 - (i) fire and rescue authority
 - (ii) ambulance
 - (iii) providing a response to an emergency at the request of an NHS ambulance service
 - (iv) bomb or explosive disposal
 - (v) special forces
 - (vi) police
 - (vii) National Crime Agency
- (b) A vehicle being used by or on behalf of a statutory undertaker in pursuance of a statutory power or duty where the observance of the provision of this order would prevent the use of that vehicle for that purpose.
- (c) A vehicle being used by or on behalf of the Council in pursuance of a statutory power or duty where the observance of the provision of this order would prevent the use of that vehicle for that purpose.
- (d) A vehicle complying with any direction of a constable in uniform or a Civil Enforcement Officer.
- (e) A vehicle being used in accordance with a waiver issued in writing by the Council which exempts that vehicle from one or more provisions of this order provided that any terms and conditions specified are complied with.
- (f) A vehicle which has undertaken a movement or action which would otherwise be in contravention of this order due to circumstances beyond the drivers control or in order to prevent an accident

PART SEVEN – PERMITS

ELIGIBILITY FOR PERMITS

- 7.1** Any person, partnership or body corporate who meets the criteria specified in column 3 of schedule A is eligible for a Permit of the type specified in column 1 of schedule B.

APPLICATION FOR PERMITS

- 7.2** An application for a Permit must be made in the manner specified by the Council.
- 7.3** The Council may require an applicant to produce evidence to verify the information provided as part of an application for a Permit.

ISSUE OF PERMITS

- 7.4** On receipt of an application for a Permit, the Council upon being satisfied that the applicant is eligible and meets all relevant requirements will issue a Permit.
- 7.5** The Council reserves the right to vary the eligibility, application process and terms for the issue of a Parking Permit as it considers appropriate.
- 7.6** Notwithstanding the preceding articles, the issuing of Permits is at the complete discretion of the Council and Permits may be issued on an exceptional basis as the Council considers appropriate.

VALIDITY OF PERMITS

- 7.7** A Permit is only valid for use in connection with the restrictions specified in column 3 of schedule A, provided that it is used in accordance with any conditions of use specified in column 5 of schedule A.
- 7.8** A Permit will cease to be valid in the following circumstances:
- (a) After a specified expiry date, or
 - (b) The Permit holder no longer meets the eligibility criteria for the Permit, or
 - (c) The withdrawal of the Permit by the Council.

WITHDRAWAL AND SURRENDER OF PERMITS

- 7.9** A Permit holder may surrender a Permit to the Council at any time.
- 7.10** A Permit holder must surrender a Permit to the Council in the circumstances specified in article 7.8.
- 7.11** The Council may serve notice of the withdrawal of a Permit in writing to the Permit holder at the address given on the application or at any other address believed to be the Permit holders residence or place of business; on receipt of this notice the Permit holder must surrender the Permit to the Council within 14 days.

FORM OF PERMITS

- 7.12** A Permit may be issued in a physical or a virtual form.
- 7.13** Where a physical Permit has been issued from it must be displayed, in the case of a vehicle fitted with a transparent windscreen so that it is facing upwards and can be entirely and easily seen from outside the vehicle, or in the case of a vehicle which is not fitted with a transparent windscreen, in a conspicuous position on the vehicle.

PART EIGHT – CONTRAVENTION & REVOCATIONS

CONTRAVENTION

- 8.1** Any person who causes or permits a vehicle to be used contrary to the provisions of this Order will be contravention of this Order and will be guilty of an offence for which a penalty charge will apply.

REVOCATIONS

- 8.2** The City of Southampton (Various Roads) (Movement Restrictions) Traffic Regulation Order 2010 is revoked in its entirety.
