

PUBLIC NOTICE

THE CITY OF SOUTHAMPTON (BARGATE DEVELOPMENT) ORDER 2022

NOTICE IS HEREBY GIVEN THAT SOUTHAMPTON CITY COUNCIL as part of the regeneration of the Bargate Quarter, with its revised layout, proposes to make the above Order, the effects of which would be:

1.
 - a. **East Street**, *north side*, From Queen's Way, westwards for 21m and *south side*, From Queen's Way, westwards for 18m
(Note: these replace No Waiting restrictions)
 - b. **Strand**, *all sides* for its entire length
(Note: this removes Pay and display parking on the east side)
 - c. **Queen's Way**, *west side*, from 14m north of East Street, northwards for 2m; From 29m north of East Street northwards for 55m; From 24m north of Canal Walk northwards to East Street
(Note: This removes the Pay and display parking in Queen's Way, west side, between East Street and The Strand and replaces No waiting restrictions west side between Canal Walk and East Street. Also, lengths of the No waiting at any time will be overlaid by the proposed Toucan crossing)
2. To relocate *No Stopping except Taxis* in **Queen's Way**, *west side*, to 16m north of East St, northwards for 13m.
3. To introduce *Goods Vehicle Loading Only (max stay 30 minutes)* in the following lengths of road:
 - a. **Queen's Way**, *west side*, from 20m south-east of the Strand, south-eastwards for 18m
 - b. **York Buildings**, *north side*, From 47m west of Queen's Way, westwards for 19m
4. To remove the *One-way* restriction in the following lengths of road:
 - a. **Strand**, for its entire length
 - b. **York Buildings**, between its junctions with Queen's Way and York Buildings Service Road
(Note: a one-way restriction will still apply southbound between York Buildings Service Road and East Street)
5. To update the restrictions applying to York Walk (off of York Buildings), to reflect the restrictions as they appear on-street and the renaming of York Walk (off of Hanover Buildings) as Hanover Buildings Service Road.
