

# PUBLIC NOTICE

## THE CITY OF SOUTHAMPTON (WAITING RESTRICTIONS AMENDMENT NO.2) ORDER 2022

NOTICE IS HEREBY GIVEN THAT SOUTHAMPTON CITY COUNCIL proposes to make the above Order, the effects of which would be:

1. To introduce No Waiting at Any Time restrictions in the following lengths of road:
  - (a) **Fort Road**, *west side*, From 10m south of its junction with Porchester Road, southwards for 5m
  - (b) **Oakwood Drive(Spur) (27-95)**, *both sides*, From its junction with Oakwood Drive(Spine) north-eastwards for 10m
  - (c) **Oakwood Drive (Spine)**, *east side*, From 10m north-west of the northern kerb-line of Oakwood Drive (Spur)(27-95) to 10m south-east of the south-eastern kerb-line of Oakwood Drive(Spur)(27-95).
  - (d) **Hill Lane**, *east side*, from opposite the northern kerb-line of Lordswood Gardens southward for 15m.
  - (e) **Arliss Road**, *south-east side*, from its junction with Romsey Road north-eastwards for 30m.
  - (f) **Sutherland Road**, *northwest side*, From 10m south-west of its junction with Rownhams Road North, north-eastward to 10m northeast of its junction with Menzies Close; *southeast side*, From 10m south-west of its junction Menzies Close to 10m north-east of its junction with Menzies Close.
  - (g) **Menzies Close**, *both sides*, From its junction with Sutherland Road southward for 10m.
  - (h) **Rownhams Road North**, *both sides*, From its junction with Sutherland Road northwards for 40m.
  - (i) **Luccombe Place**, *both sides*, from 10m east of its junction with Luccombe Road to 10m west of its junction with Luccombe Road
  - (j) **Luccombe Road**, *both sides*, from 10m south of its junction with Luccombe Place to 10m north of its junction with Luccombe Place; and From its junction with Bellemoor Road northward for 13m
  - (k) **Pentire Avenue**, *both sides*, from its junction with Bellemoor Road northward for 10m
  - (l) **Shanklin Road**, *both sides*, from its junction with Bellemoor Road northward for 10m
  - (m) **Bellemoor Road**, *north side*, from 10m west of the western kerb-line Pentire Avenue to 10m east of the eastern kerb-line Pentire Avenue; From 10m west of the western kerb-line Luccombe Road to 10 m east of the eastern kerb-line Luccombe Road; and From 10m west of the western kerb-line of Shanklin Road to 10 m east of the eastern kerb-line Shanklin Road
2. To remove No Waiting at Any Time restrictions in **Melchet Road**, *south side*, From 10m southwest of its junction with Beauworth Avenue, south-westwards for 5m
3. To introduce No Loading at Any Time restrictions in the following length of road:
  - (a) **Mount Pleasant Road**, *both sides*, From its junction with Derby Road eastwards to the train level crossing
  - (b) **Northumberland Road**, *west side*, From its junction with Mount Pleasant Road to the southern closed end of its northern section;  
*east side*, From its junction with Mount Pleasant Road southwards for 14m; and From 29m south of Mount Pleasant Road to the southern closed end of its northern section
  - (c) **Manor House Avenue (northwest to southeast arm)**, *both sides*, For its entirety.
