THE CITY OF SOUTHAMPTON (EAST PARK TERRACE) (CYCLE FACILITIES) NOTICE 2023

NOTICE IS HEREBY GIVEN THAT SOUTHAMPTON CITY COUNCIL in accordance with section 65 and section 66 of the Highways Act 1980 intends to construct the following cycle tracks:

- 1. Shared-use cycle tracks in:
 - a. **East Park Terrace Footways**, *east side*, From 16m south of its junction with Charlotte Place Roundabout Footways south-westwards for 9m.
 - b. East Park Terrace Footways, central island, For the entire accessible area (reconfigured).
 - c. East Park Terrace Footways and East Park Terrace (carriageway), west side, An area approximately 3m by 9m adjoining the East Park Footpath.
 - d. **East Park Terrace Footways**, *both* sides, From 147m north of the northern kerbline of New Road northwards for 34m.
 - e. **Palmerston Road Footways**, east side, From 2.5m north of the northern boundary of Craven Walk southwards for 10m.
 - f. **Palmerston Road Footways**, west side, From 66m south of the southern kerbline of New Road southwards for 64m.
- 2. Segregated with-flow cycle track in:
 - a. **East Park Terrace (carriageway)**, east side, From 25m south of its junction with Charlotte Place Roundabout southwards for 69m and From 18m north of the northern kerbline of New Road northwards for 25m.
 - b. **East Park Terrace (carriageway)**, west side, From 11m south of its junction with Charlotte Place Roundabout southwards for 85m and From 28m north of the northern kerbline of New Road northwards for 36m.
 - c. **Palmerston Road (carriageway)**, east side, From 27m south of the southern kerbline of New Road southwards for 20m. *Note the cycle route will be continued southbound as an advisory cycle lane for 38m*.
 - d. **Palmerston Road (carriageway) and Palmerston Road Verges**, west side, From 9m south of the southern kerbline of New Road southwards for 57m.
