

PUBLIC NOTICE

THE CITY OF SOUTHAMPTON (MINOR TRAFFIC REGULATION SCHEMES) (NO.2) ORDER 2023

NOTICE IS HEREBY GIVEN THAT SOUTHAMPTON CITY COUNCIL proposes to make the above Order, the effects of which would be:

To introduce No Waiting at Any Time restrictions in the following lengths of road:

- a. **Blakeney Road**, *Both sides*, From 10m north-west of the north-western kerb-line of Hayburn Road south-eastwards to 10m south-east of the south-eastern kerb-line of Hayburn Road.
- b. **Dunvegan Drive**, *Both sides*, From 10m west of the western kerb-line of Melville Close eastwards to 10m east of the eastern kerb-line of Melville Close.
- c. **Glen Road**, *North-west side*, From 5m east of the boundary of number 41 and number 43 for 5m (in place of existing permit parking restrictions)
- d. **Guildford Street**, *All sides*, For its entire length
- e. **Hayburn Road**, *Both sides*, From the south-western kerb-line of Blakeney Road south-westward for 10m.
- f. **Medwall Green**, *Both sides*, From the north-eastern kerb-line of Tatwin Crescent north-eastwards for 10m
- g. **Melville Close**, *Both sides*, From the southern kerb-line of Dunvegan Drive southwards for 10m.
- h. **Middle Road**, *Both sides*, From its junction with Station Road northwards for 10m.
- i. **Redbridge Hill**, *Both sides*, From the south-western kerb-line of Romsey Roads south-westwards for 30m
- j. **Squirrel Drive**, *Both sides*, From its junction with Station Road northwards for 10m.
- k. **Station Road**, *South side*, From 10m west of the western kerb-line of Middle Road eastwards to 10m east of the eastern kerb-line of Station Road, From 10 west of the western kerb-line of Squirrel Drive eastwards to 10m east of the eastern kerb-line of Squirrel Drive.
- l. **Tatwin Crescent**, *East side*, From 10m south-east of the south-eastern kerb-line of Medwall Green north-westwards to 15m south of the southern kerb-line of Tatwin Close; *West side*, From 10m north-east of the north-eastern kerb-line of Medwall Green south-eastwards to 10m south-east of the south-eastern kerb-line of Medwall Green.
- m. **Wilson Street**, *All sides*, For its entire length

To introduce No Waiting During Restricted Hours (8:15-9:15am and 14:30-16:00pm Mon-Fri) in the following lengths of road:

- a. **Newtown Road**, *Both sides*, From 1m east of the property boundary of number 24 and number 26 to the property boundary between number 44 and number 46; From the property boundary of number 58 and 60 to 1m west of the property boundary of number 74 and number 76

To update the traffic order to reflect the correct street name for Mansfield Park Street (Exford Drive) following a change in name as part of its process:

- a. **Mansfield Park Street**, *All sides*, For their entire lengths

To update the traffic order to reflect those restrictions that are on street:

- a. **London Road**, *north-west side*, From 89m north-east of the north-eastern kerblines of Carlton Crescent north-eastwards for 10m (removal of No Stopping at Any Time, Except Taxis from the traffic order and replacing this with no waiting at any time restrictions)

Note: This notice has been updated to include Newtown Road which was initially omitted in error.
