## THE CITY OF SOUTHAMPTON (RESIDENTS PARKING) (ZONES 1-12 & 16) (AMENDMENT 29) ORDER 2024

NOTICE IS HEREBY GIVEN THAT SOUTHAMPTON CITY COUNCIL proposes to make the above Order, the effects of which would be:

- 1. To introduce No Waiting at Any Time in **John Thornycroft Road**, *both sides*, between its junction with Victoria Road (to be built) and Oswald Road
- **2.** To introduce No Waiting at Any Time in **John Thornycroft Road**, *northwest side*, in place of the No Stopping except Taxis adjacent to the Woolston Library.
- **3.** To introduce No Waiting at Any Time on the *north-western* side of **Victoria Road** between 145 Victoria Road and 201 Victoria Road, except where point 4 applies:
- **4.** To introduce Permit Holder Only parking, 8am 8pm, in the following lengths of **Victoria Road**, *north-west side*;
  - a. From 13.5m south of its junction with John Thornycroft Road, southwards for 12m
  - b. From 9m south of its junction with Oswald Road, southwards for 25m
  - c. From 36m south of its junction with Oswald Road, southwards for 17m
  - d. From 55m south of its junction with Oswald Road, southwards for 19m
  - e. From 76m south of its junction with Oswald Road, southwards for 23m
- **5.** To update the Order to reflect the restrictions as they appear on-street for the following roads; **John Thornycroft Road** and **Keel Road**.
