### 1 Introduction

- 1.1 This report results from a Stage 3 Road Safety Audit carried out on the bus gate trial on Portswood Road between the Westridge Road and St Denys Road junctions in Southampton. The works primarily consist of the signing associated with the bus gate prohibitions, installation of monitoring/enforcement cameras, carriageway surfacing works along with bus and cycle improvements. This Stage 3 Road Safety Audit also includes the scheme to reduce the number of vehicles rat-running through residential streets adjacent to Portswood Road as a result of the proposed bus gate trial. The Audit Team were made aware that the streetlight dimming and part night lighting had been removed along Brookvale Road. The audit has been carried out on behalf of Balfour Beatty Living Places.

- 1.3 The Road Safety Audit comprised an examination of the documents provided, as listed in the Road Safety Audit Brief for each scheme, which were provided by Balfour Beatty Living Place via emails and received on 19 February 2025.
- 1.4 The Audit Team initially visited the site on 12 February 2025 between 8:00am and 9:00am. Traffic conditions were low on Portswood Road, as a result of the bus gate being in operation, and medium to heavy on the surrounding roads. A low to medium level of pedestrian and cycle activity was observed during the site visit. Following this site visit the Audit Team recommended that the priority feature on Brookvale Road between Winn Road and Blenheim Road should be removed due to observed conflict between opposing vehicles.

The Audit Team visited the site again on 11 March 2025 between 2:30pm and 7pm. During the visit the weather was cloudy but dry, and the existing road surface was dry. Traffic conditions were variable between moderate and heavy on Portwood Road and the surrounding roads with medium to high levels of pedestrian and cycle activity observed throughout the duration of the site visit. The priority feature on Brookvale Road between Winn Road and Blenheim Road had been removed prior to this site visit. The Audit Team remained on site to observe the combined scheme measures in darkness.
