

**THE CITY OF SOUTHAMPTON
(RESIDENTS PARKING) (ZONES 1-12 & 16) (AMENDMENT 31) ORDER 2025**

Southampton City Council in exercise of its powers under Sections 1, 2, 45, 46 and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984 and of all other enabling powers, after consultation with the Chief Office of Police in accordance with Part III of Schedule 9 to that Act hereby makes the following Order:

CITATION

- 1 This Order shall come into operation on **DD MONTH YEAR** and may be cited as The City of Southampton (Residents Parking) (Zones 1-12 & 16) (Amendment 31) Order 2025

INTERPRETATION

- 2 In this Order:
- (i) "Principal Order" means The City of Southampton (Residents Parking) (Zones 1-12 & 16) (Amendment 31) Order 2011, as amended.
 - (ii) Except where otherwise stated, any reference to an Article or Schedule shall be construed as a reference to that article or schedule in this Order.
 - (iii) Any reference to an enactment shall be construed as a reference to that enactment as amended by any subsequent enactments.

AMENDMENTS

- 3 The contents of Schedule 1 shall be deleted from Schedule 2.04 of the Principal Order.
- 4 The contents of Schedule 2 shall be deleted from Schedule 2.01 of the Principal Order.
- 5 The contents of Schedule 3 shall be added to Schedule 2.01 of the Principal Order.

Schedule 1 – No Waiting 8am-6pm Mon-Fri (Deletion from Schedule 2.04 – Principal Order)

Road	Side	Description
Hazel Road	West	From a point 40m north of the extended southern kerb-line of Sea Road northwards for 110m

Schedule 2 – No Waiting at Any Time (Deletion from Schedule 2.01 – Principal Order)

Road	Side	Description
Hazel Road	West	From a point 15m south of the extended southern kerb-line of Sea Road northwards to a point 40m north of the extended southern kerb-line of Sea Road
Hazel Road	East	From the north-western kerb-line of Oakbank Road northwards to a point 43m north of the southern kerb-line of Sea Road

Schedule 3 – No Waiting at Any Time (Addition to Schedule 2.01 – Principal Order)

Road	Side	Description
Hazel Road	West	From 15m south of the extended kerb-line of Sea Road northwards to the northern boundary of the adopted highway
Hazel Road	East	From the north-western kerb-line of Oakbank Road northwards to the northern boundary of the adopted highway
Hazel Road	Closed end (of the adopted highway)	For its entire length
