

# PUBLIC NOTICE

## THE CITY OF SOUTHAMPTON (VARIOUS ROADS) (PROHIBITION AND RESTRICTION OF WAITING) (AMENDMENT 90) ORDER 2025

NOTICE IS HEREBY GIVEN THAT SOUTHAMPTON CITY COUNCIL proposes to make the above Order, the effects of which would be:

- 1 To introduce No Waiting at Any Time restrictions in **Weston Parade**:
  - a. *north east side*, From 80m south-east of its junction with the Weston Shore (Weston Lane) Car Park south-eastwards to the city boundary.
  - b. *south west side*, From 165m south-east of its junction with the Weston Shore (Weston Lane) Car Park south-eastwards for 63m, From 343m south-east of its junction with the Weston Shore (Weston Lane) Car Park south-eastwards for 63m, From 513m south-east of its junction with the Weston Shore (Weston Lane) Car Park south-eastwards for 85m, From 658m south-east of its junction with the Weston Shore (Weston Lane) Car Park south-eastwards to the city boundary.
- 2 To introduce Parking Places with 6-hour limit 6am – 10pm Monday – Sunday (No Return within 4 hours) and No Waiting 10pm – 6am Monday – Sunday in **Weston Parade**:
  - a. *south west side*, From 62m south-east of its junction with the Weston Shore (Weston Lane) Car Park south-eastwards for 103m, From 228m south-east of its junction with the Weston Shore (Weston Lane) Car Park south-eastwards for 115m, From 406m south-east of its junction with the Weston Shore (Weston Lane) Car Park south-eastwards for 107m, and From 598m south-east of its junction with the Weston Shore (Weston Lane) Car Park south-eastwards for 60m
- 3 To prohibit overnight parking (midnight – 4am) in the Weston Shore (Weston Lane) Car Park and the Weston Shore (Weston Parade) Car Park.
