# THE CITY OF SOUTHAMPTON (VARIOUS ROADS) (PROHOBITION AND RESTRICTION OF WAITING) (AMENDMENT 90) ORDER 2025

Southampton City Council in exercise of its powers under Sections 1, 2, 45, 46 and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984 and of all other enabling powers, after consultation with the Chief Office of Police in accordance with Part III of Schedule 9 to that Act hereby makes the following Order:

#### CITATION

This Order shall come into operation on DD MONTH YEAR and may be cited as The City of Southampton (Various Roads) (Prohibition and Restriction of Waiting) (Amendment 90) Order 2025

#### INTERPRETATION

- 2 In this Order:
  - (i) "Principal Order 1" means The City of Southampton (Various Roads) (Prohibition and Restriction of Waiting) Order 2011, as amended.
  - (ii) "Principal Order 2" means The City of Southampton (Suburban Off-Street Parking Places) Order 2019, as amended.
  - (iii) Except where otherwise stated, any reference to an Article or Schedule shall be construed as a reference to that article or schedule in this Order.
  - (iv) Any reference to an enactment shall be construed as a reference to that enactment as amended by any subsequent enactments.

#### **AMENDMENTS**

- 3 The following shall be inserted into Principal Order 1 after Article 5(B):
  - Any vehicle to wait between the hours of 6.00am to 10.00pm, Monday to Sunday, for a longer period than 6 hours, or if a period of less than 4 hours has elapsed since the termination during the said hours of the last period of waiting of the vehicle (if any) in the parking places specified in Schedule 6.33."
- 4 The following shall be inserted into Principal Order 1 after Article 3:
  - **"3(xvii)** between the hours of 10.00pm-6.00am, Monday-Sunday in the lengths of road or on the side roads specified in Schedule 2.28."
- **5** The following shall be inserted into Principal Order 2 after Article 2.11:
  - **\*2.11B** No person shall cause or permit any vehicle to be left in in the Parking Places specified in columns 1 and 2 of schedule 1 outside the hours specified in column 8 of schedule 1."
- 6 The contents of Schedule 1 shall be inserted into Principal Order 1 as a new Schedule 6.33.
- 7 The contents of Schedule 2 shall be inserted into Principal Order 1 as a new Schedule 2.28.
- 8 The contents of Schedule 3 shall be inserted into Schedule 2.01 of Principal Order 1.

The contents of Schedule 1 of Principal Order 2 shall be deleted and replaced with the 9 contents of Schedule 4.
