PUBLIC NOTICE

THE CITY OF SOUTHAMPTON (STATIC RESTRICTIONS) (WEST) (AMENDMENT 7) ORDER 2025

NOTICE IS HEREBY GIVEN THAT SOUTHAMPTON CITY COUNCIL proposes to make the above Order, the effects of which would be:

- 1. To introduce no waiting at any time restrictions in the following lengths of road:
 - a) Waltham Crescent, *both sides*, from its western junction with Aldermoor Road Northwards for 4m, and From its eastern junction with Aldermoor Road Northwards for 10m.
 - b) Waltham Crescent, *north side*, from 10m west of its junction with Purbrook Close to 10m east of that junction, and from 10m south of its junction with Bransbury Close to 10m south of that junction.
 - c) Bransbury Close, both sides, for its entire length
 - d) Purbrook Close, east side, for its entire length
 - e) Purbrook Close, *west side*, from its junction with Waltham Crescent northwards for 7m, from 15m north of its junction with Waltham Crescent northwards for 6m, and from 35m north of its junction with Waltham Crescent to its northern closed end
 - f) Service Road from Aldermoor Rd to the rear of 237 247 Aldermoor Road (Aldermoor Road Car Park), east side, from its junction with Aldermoor Road northwards for 14, and from 27m north of its junction with Aldermoor Road northwards for 10m
- 2. To introduce permit holders only restrictions, Monday Friday 8am-6pm on:
 - a) Waltham Crescent, inner side, from 10m north of its western junction with Aldermoor Road to 10m north of its eastern Junction with Aldermoor Road
 - b) Waltham Crescent, outer side, from 10m north of its western Junction with Aldermoor Road to 10m west of its junction with Purbrook Close, from 10m east of its junction with Purbrook Close to 10m west of its junction with Bransbury Close, and from 10m south of its junction with Bransbury Close to 10m north of its eastern junction with Aldermoor Road.
 - c) Purbrook Close, west side, from 7m north of its junction with Waltham Crescent northwards for 8m, and from 21m north of its junction with Waltham Crescent northwards for 14m
- 3. To introduce a loading bay on the Service Road from Aldermoor Rd to the rear of 237 247 Aldermoor Road (Aldermoor Road Car Park), east side from 14m north of its junction with Aldermoor Road northwards for 12m.
