THE CITY OF SOUTHAMPTON (E-SCOOTER AND CYCLE HIRE PARKING) ORDER 2025

Southampton City Council in exercise of its powers under Sections 1, 2, 32, 35, and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984 and of all other enabling powers, after consultation with the Chief Office of Police in accordance with Part III of Schedule 9 to that Act hereby makes the following Order:

CITATION

1 This Order shall come into operation on XX XXXX 2025 and may be cited as The City of Southampton (E-scooter and Cycle Hire Parking) Order 2025.

INTERPRETATION

- 2 In this Order:
 - (i) "Principal Order 1" means The City of Southampton (Various Roads) (Prohibition and Restriction of Waiting) Order 2011, as amended.
 - (ii) "Principal Order 2" means The City of Southampton (Northam, Bitterne Manor & Itchen) (Residents' Parking Scheme) Order 2008, as amended.
 - (iii) Except where otherwise stated, any reference to an Article or Schedule shall be construed as a reference to that Article or Schedule in this Order.
 - (iv) Any reference to an enactment shall be construed as a reference to that enactment as amended by any subsequent enactments.
