Southampton City Council in exercise of its powers under Sections 1, 2 and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984 and of all other enabling powers, after consultation with the Chief Office of Police in accordance with Part III of Schedule 9 to that Act hereby makes the following Order:

CITATION

1 This Order shall come into operation on Date and may be cited as The City of Southampton (Moving Traffic Restrictions) (Amendment 4) Order 2025.

INTERPRETATION

- 2 In this Order:
 - (i) "The Principal Order" means The City of Southampton (Moving Traffic Restrictions) Order 2022.
 - (ii) Except where otherwise stated, any reference to an Article or Schedule shall be construed as a reference to that Article or Schedule in this Order.
 - (iii) Any reference to an enactment shall be construed as a reference to that enactment as amended by any subsequent enactments.

AMENDMENTS

- 3 The following definition shall be inserted into Article 1.3 of the Principal Order:
 - "School Streets Permits and Access Guidance" means the document which sets out the eligibility criteria for access, application process and enforcement dates for School Streets schemes.
- 4 The contents of Schedule 1 shall be deleted from Schedule A to the Principal Order.
- 5 The contents of Schedule 2 shall be added to Schedule A to the Principal Order.
