THE CITY OF SOUTHAMPTON (ST MONICA SAFER ROUTES TO SCHOOL) TRAFFIC REGULATION ORDER 2025

Southampton City Council in exercise of its powers under Sections 1, 2, 4, 35, 45, 46, 49 and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984 (the 1984 Act) and of all other enabling powers, after consultation with the Chief Office of Police in accordance with Part III of Schedule 9 of the 1984 Act hereby makes the following Order:

PART ONE - INTRODUCTION

COMMENCEMENT AND CITATION

This Order shall come into operation on the [DATE] and may be cited as The City of Southampton (St Monica Safer Routes to School) Traffic Regulation Order 2025.

INTERPRETATION

- 2 In this Order:
 - (i) "Principal Order 1" means The City of Southampton (Various Roads) (Prohibition and Restriction of Waiting) Traffic Regulation Order 2011, as amended.
 - (ii) "Principal Order 2" means The City of Southampton (Moving Traffic Restrictions) Order 2022, as amended.
 - (iii) Except where otherwise stated, any reference to an Article or Schedule shall be construed as a reference to that Article or Schedule in this Order.
 - (iv) Any reference to an enactment shall be construed as a reference to that enactment as amended by any subsequent enactments.
