THE CITY OF SOUTHAMPTON (OFF-STREET PARKING PLACES) (AMENDMENT 3) ORDER 2025

Southampton City Council in exercise of its powers under Sections 1, 2, 32, 35, 45, 46 and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984 and of all other enabling powers, after consultation with the Chief Office of Police in accordance with Part III of Schedule 9 to that Act hereby makes the following Order:

CITATION

1. This Order shall come into operation on [DATE] and may be cited as The City of Southampton (Off-Street Parking Places) (Amendment 3) Order 2025.

INTERPRETATION

- 2. In this Order:
 - (i) "Principal Order" means The City of Southampton (Off-Street Parking Places) Order 2022, as amended.
 - (ii) Except where otherwise stated, any reference to an Article or Schedule shall be construed as a reference to that Article or Schedule in this Order.
 - (iii) Any reference to an enactment shall be construed as a reference to that enactment as amended by any subsequent enactments.

AMENDMENTS

- **3.** The contents of article 2.24 of the Principal Order shall be deleted and replaced with the following:
 - "Those Parking Places specified as "pay on foot" in column 5 of schedule 1 shall be controlled by barriers at the entry and exit points. The driver of a vehicle shall gain entry by taking a ticket at the entry barrier or following an Automatic Number Plate Recognition (ANPR) system recording the vehicles registration. This ticket or the vehicles registration shall be submitted to a pay station (or submitted via phone or app where available) at the end of the parking period and payment made of the appropriate charge for the length of stay as specified in schedule 2. The driver of the vehicle shall exit by submitting a validated ticket or following recognition of payment by the ANPR system at the exit barrier."
- **4.** The contents of article 4.2 of the Principal Order shall be deleted and replaced with the following:
 - "Article 2.24 and Article 2.25 shall not apply to motorcycles parked within the designated motorcycle parking bays. Motorcycles not parked within the designated motorcycle parking bays must pay the appropriate charge for the length of stay as specified in schedule 2 via the pay station (or submitted via phone or app where available)."
- **5.** The contents of Schedule 1 shall be deleted from Schedule 1 of the Principal Order.
- **6.** The contents of Schedule 2 shall be inserted into Schedule 1 of the Principal Order.
- 7. The contents of Schedule 3 shall be deleted from Schedule 2 of the Principal Order.
- **8.** The contents of Schedule 4 shall be inserted into Schedule 2 of the Principal Order.
